

TOP 10 THINGS EVERY GA VOTER SHOULD KNOW FOR THE 2016 ELECTION

1

THE VOTER REGISTRATION DEADLINE IS OCTOBER 11, 2016.

Go to **registertovote.sos.ga.gov** to complete and submit *or* download and print a voter registration application. You **must** register in order to vote.

TO BE ELIGIBLE TO VOTE IN GEORIGA, YOU MUST BE:

- At least 18 years of age by November 8, 2016;
- · A citizen of the United States;
- A resident of the state of Georgia or the county or municipality in which you register to vote; and
- If convicted of a felony, completed your sentence (including incarceration, parole, and all fines, fees and restitution paid).

PROVING U.S. CITIZENSHIP

You can provide proof of citizenship documents to the County Election Office during early voting and on Election Day and vote a regular ballot if you registered by the voter registration deadline of October 11, 2016.

ELECTION DAY IS NOVEMBER 8, 2016.

- Polls will be open from 7 AM to 7 PM on Election Day.
- On Election Day, voters must vote in their county and assigned voting precinct.
- Every qualified voter who is standing in line by 7 PM has a right to cast a ballot.
- To check your Election Day voting location or review a sample ballot, contact your County Election Office or go to mvp.sos.ga.gov

DON'T WAIT UNTIL ELECTION DAY TO CHECK YOUR REGISTRATION STATUS

YOU MUST PRESENT A VALID PHOTO ID TO VOTE

When you arrive at your polling place, you will be required to present one of the following forms of identification:

- ✓ Georgia Driver's license
- A photo ID issued by a state or federal government agency
- ✓ Student ID
- → Employee ID issued by any branch of government
- ✓ U.S. Passport
- ✓ Military ID
- ✓ Tribal ID
- Free voter ID card issued by your County Election Office or the GA Department of Driver Services

If you do not have a valid photo ID, you can vote a provisional ballot. However, your ballot will not be counted unless you bring an acceptable form of photo ID to your County Election Office **no later than November 11, 2016.**

YOU CAN VOTE EARLY IN-PERSON OR BY MAIL-IN ABSENTEE BALLOT

- Early Voting Dates are October 17 through November 4, 2016.
- During the early voting period, any registered voter may vote in-person at his or her County Election Office or at other designated locations within the county.
- To check your early voting location or early voting hours contact your County Election Office visit mvp.sos.ga.gov
- To request an absentee ballot, submit a written application to your County Election Office or go to mvp.sos.ga.gov to download and print an application. There is no deadline to submit a request for an absentee ballot. However, it is recommended you do so before November 7, 2016.
- Your absentee ballot must be received by your County Election Office no later than 7pm on Election Day.

YOU HAVE THE RIGHT TO ASSISTANCE AT YOUR POLLING PLACE

- You have the right to obtain assistance to vote due to physical disability, limited-English proficiency, or inability to read or write from someone of your choice except your employer or a union representative.
- Under the federal law, each polling place is required to have at least one voting machine that is accessible to voters with physical disabilities.
- Between the hours of 9:30 AM and 4:30 PM on Election Day, voters who are 75 years of age or older or who are physically disabled may, upon request to a poll worker, vote immediately without waiting in line.

KNOW YOUR RIGHTS IF YOU ARE CHALLENGED

- It is illegal for individuals to "challenge" your eligibility to vote on the basis of your race.
- If your eligibility to vote is "challenged" on the basis that you are in the wrong precinct, ask a poll worker to identify your correct precinct and direct you to that precinct.
- If your eligibility to vote is "challenged" for any other reason, you have a right to a same-day hearing before the County Election Board. Challenges must be made in writing and must state the reasons for the challenge.

VOTE A PROVISIONAL BALLOT ONLY AS A LAST RESORT

You have a right to vote a provisional ballot if you believe that you are a registered voter but your name is not on the voter rolls. Provide written evidence of your eligibility to your County Election Office **no later than November 11, 2016** for your vote to count.
