# **What Every Florida Voter Should Know**

## **Registration Deadline**

Florida's deadline to register to vote is Monday, October 5, 2020.

## Requesting to Vote-By-Mail?

The deadline to request to Vote By Mail is Saturday, October 24, 2020 by 5pm.

## **Early Voting Dates**

Every county is required to have early voting from **October 24 – 31, 2020**. County Supervisors of Elections may choose to host early voting on these additional dates: October 19, 20, 21, 22, 23 and November 1. Contact your county Supervisor of Elections' office or look their information up at <a href="https://dos.elections.myflorida.com/supervisors">https://dos.elections.myflorida.com/supervisors</a>.

#### **Election Day**

Election Day is November 3, 2020 and the polls are open from 7am to 7pm. If you are in line when the polls close, you are entitled to vote.

## **Vote-By-Mail Ballot Return**

Whether you mail it back or drop it off, your County Supervisor of Elections' office must receive your vote-by-mail ballot by 7pm on Election Day. If you change your mind and decide you'd rather vote in person on Election Day, you can bring your vote-by-mail ballot to your poll location. Once you surrender it to a poll worker, you can vote a regular ballot.

## **Vote-By-Mail Requirements**

Make sure to sign the ballot envelope. You can track the status of your ballot at <a href="https://registration.elections.myflorida.com/CheckVoterStatus">https://registration.elections.myflorida.com/CheckVoterStatus</a>. If there are any issues with your ballot, such as forgetting to sign the ballot or envelope, you may "cure" these issues until 5pm on the second day after the election. #### **Voting in Person**

If you are voting in person, you must show one of the following valid photo IDs containing a picture and signature: (1) Florida driver's license; (2) Florida ID card issued by the Department of Highway Safety and Motor Vehicles; (3) U.S. passport; (4) Debit or credit card; (5) Military ID; (6) Student ID; (7) Retirement center ID; (8) Neighborhood association ID; (9) Public assistance ID; (10) Veteran health ID card issued by the U.S. Dept. of Veteran Affairs; (11) A concealed weapon or firearm license; or (12) Employee ID issued by the federal, state, county, or a municipality.

**Note on Signatures:** If your photo ID does not include a signature, you must produce additional ID from the list above that includes your signature. If the signature on your photo ID does not match the signature on the voting precinct register, a poll worker will instruct you to complete an affidavit affirming your identity and qualification to vote in the county. Once you complete the affidavit, the poll worker should give you a regular ballot.
